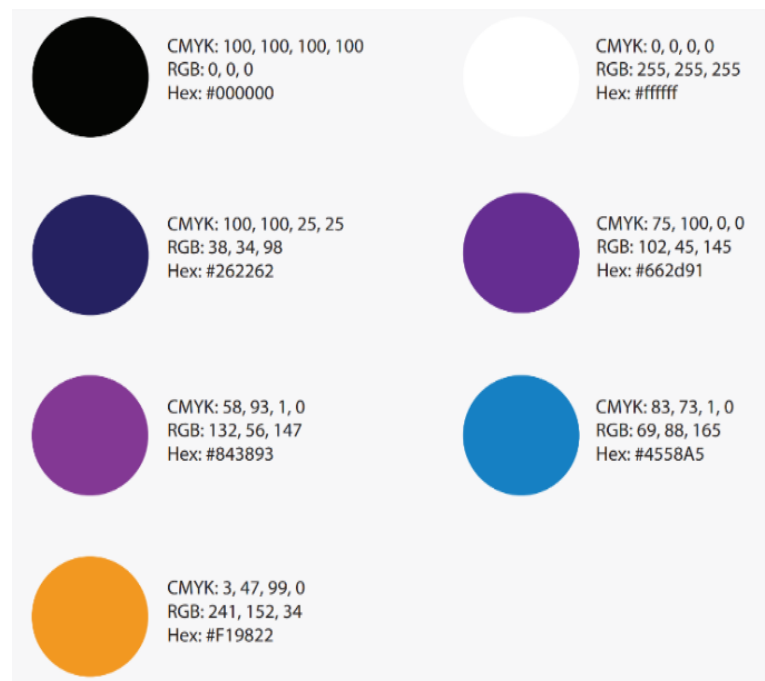
The artist who submits the winning design will:

CONFERENCE COLOR PALETTE & THEME LOGO

Below is a sample of this year's theme and logo along with the color palette for the conference. Art contest covers are not required to use the color palette or design theme.



The 2026 Los Angeles County Women's Leadership Conference (LACWLC) is scheduled to take place on Thursday, September 10, 2026, at the Pasadena Convention Center.

Use your creativity to design a program cover conveying the message behind the theme: Innovate, Influence, Inspire. The winning designer's artwork will be used as inspiration for the event's program cover, website, social media, and other promotional materials for the LACWLC.

RULES

- Submissions must be original artwork and designs. Submitting Designer will be required to grant an assignment of rights to authorize the County of Los Angeles (County) and LACWLC's use of the design.
- Submissions must be created entirely by the Submitting Designer and may not include artwork generated as a whole or in part using artificial intelligence (AI).
- Submissions should not include copyrighted elements from third parties. By submitting a design, the Submitting Designer represents and warrants that the submitted design does not include copyrighted elements from third parties and does not infringe any third-party intellectual property rights.
- Submissions should not contain clip art. Submissions must be in Portable Document Format (PDF) or image (electronic) format.
- Submissions should be easily scalable for multiple uses as it will be used for the program cover and other forms of promotion and advertisement.
- Submissions must be in the following art formats: computer, conceptual, drawing, graphic, photography, or painting.
- Final Size for Program 5.5" x 8.5" (portrait) or 300 dpi (portrait)
- The official LACWLC logo and *Innovate, Influence, Inspire* logo graphics will be added to the winning submission.
- Contest is open to all ages.

TERMS

Contestants must read, sign, and submit the attached waiver with their entry. If the contestant is under 18 years of age, the waiver must be signed by both the contestant and a parent/guardian.

HOW TO ENTER

Entries of artwork and scanned waiver must be submitted by email to: lacwlc@pw.lacounty.gov by Wednesday, July 8, 2026, at 5PM (PDT).

SELECTED DESIGN

The selected entry will be used for inspiration to create the Conference program cover. The designer of the selected entry will have the opportunity to collaborate with a Conference-selected graphic artist to create the 2026 Women's Leadership Conference program cover and the artwork featured in promotional materials for the Conference. In addition, the designer of the selected entry will receive one (1) ticket to the 2026 Women's Leadership Conference – Innovate, Influence, Inspire and will be featured in the conference program.
